Re: Waste Reduction Funding in Cap-and-Trade Auction Proceeds Investment Plan

Dear Ms. Nichols:

CRRA appreciates the opportunity to provide input on the Cap-and-Trade Auction Proceeds Investment Plan (Plan), and is encouraged that AB 1532 explicitly identifies reducing greenhouse gas emissions through increased in-state diversion of municipal solid waste for funding under the Plan. **We strongly support investing a portion of the Greenhouse Gas Reduction Fund in (a) recycling market development, and (b) organics processing.**

- **Expand CA recycling markets and infrastructure (missing from the concept paper)**
 - Expand the existing Recycling Market Development Zone (RMDZ) program
 - Increase performance based-investment incentives for recycling processing and recycled-content manufacturing, building on the model of California's successful Plastic Market Development Program
 - These actions would spur economic development, create jobs, and reduce direct and lifecycle GHG emissions

- **Expand CA processing of yard trimmings, food scraps, and other organic materials**
 - Reduce landfill methane emissions by providing incentives for increasing composting and digestion
