RE: AB 199 (Eggman) Recycling Market Development Sales and Use Tax Exemption – Support

Dear Senator Wieckowski,

We would like to express our strong support for Assembly Bill 199 by Assembly Member Susan Eggman, a measure that will increase recycling and help develop domestic markets for recycled materials.

AB 199 will add recycled content manufacturing and processing to the successful Advanced Transportation and Alternative Sources Manufacturing Sales and Use Tax Exemption Program. This will provide an important incentive to increase overall recycling and reintroduce more recyclable materials into California's manufacturing economy.

The program, administered by the California Alternative Energy and Advanced Transportation Financing Authority (CAETFTA), is capped at \$100 million annually and has never reached that cap. All projects that are approved for CAETFTA sales tax exemptions have to demonstrate that any costs to the state will be offset by the increased economic activity created by the project. By definition, these projects must bring a net environmental and jobs benefit to the state.

California's commitment to recycling has diverted millions of tons of recyclables from landfills per year, cut greenhouse gases, and created 125,000 jobs over the past two decades. However, most of what we continue to send to landfills is readily recyclable or compostable. By collecting, processing and manufacturing these materials into new products in the state we can support a sustainable and prosperous California economy.

According to CalRecycle, for every ton of materials that gets recycled instead of being disposed, California's 5,300 recycling establishments will pay an additional \$101 in salaries, produce \$275 more in goods and services, and generate \$135 more in sales. Additionally, this generates a multiplier effect that supports the creation of jobs and tax revenue.

For these reasons, we urge your support on this important legislation.
